Wage Levels for 2022 Nebraska Advantage Rural Development Act and Microenterprise Tax Credit Act Applications

Issue

What is the required wage level for Nebraska Advantage Rural Development Act and the wage limit under the Nebraska Advantage Microenterprise Tax Credit Act applications filed on or after January 1, 2022?

Conclusion

Beginning with applications filed on or after January 1, 2022, an applicant must meet the following wage requirements to qualify for benefits:

Nebraska Advantage Rural Development Act	
2021 Required Wage Level	2022 Required Wage Level
\$ 14.95 per hour	\$ 16.03 per hour

Nebraska Advantage Microenterprise Tax Credit Act	
2021 Wage Limit	2022 Wage Limit
\$ 1,380 per week	\$ 1,484 per week
