### General Fund Receipts — August 2017

SEPTEMBER 15, 2017 (LINCOLN, NEB.) — **August Gross Receipts:** Tax Commissioner Tony Fulton reports that gross General Fund receipts for August were \$466 million, which is 3.1% below the certified forecast of \$481 million.

- Gross Sales and Use: 2.3% below forecast
- Gross Individual Income: 2.2% below forecast
- Gross Corporate Income: 24.4% below forecast
- Gross Miscellaneous: 17.5% below forecast

**August Tax Refunds:** Tax refunds for August were \$61 million, which is 6.7% below the certified forecast of \$66 million.

**August Net Receipts:** Net receipts for August were \$405 million, which is 2.5% below the certified forecast of \$415 million.

- Net Sales and Use: 0.5% below forecast
- Net Individual Income: 3.2% below forecast
- Net Corporate Income: 15.9% above forecast
- Net Miscellaneous: 17.5% below forecast

**Fiscal Year Net Receipts:** Net General Fund receipts for fiscal year 2017-18 were \$673 million, which is 2.6% below the certified forecast of \$691 million.

- Net Sales and Use: 1.3% below forecast
- Net Individual Income: 3.7% below forecast
- Net Corporate Income: 7.6% above forecast
- Net Miscellaneous: 6.0% below forecast

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board on April 26, 2017. This forecast was adjusted for legislation passed in 2017, divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on July 14, 2017.
