General Fund Receipts — June 2018

July 13, 2018 (LINCOLN, NEB.) — June Gross Receipts: Tax Commissioner Tony Fulton reports that gross General Fund receipts for June were \$566 million, which is 4.9% above the certified forecast of \$539 million.

Gross Sales and Use: 3.1% above forecast
Gross Individual Income: 2.1% above forecast
Gross Corporate Income: 25.6% above forecast
Gross Miscellaneous: 3.5% above forecast

June Tax Refunds: Tax refunds for June were \$92 million, which is 8.9% above the certified forecast of \$84 million.

June Net Receipts: Net receipts for June were \$474 million, which is 4.1% above the certified forecast of \$455 million.

Net Sales and Use: 5.3% below forecast
 Net Individual Income: 4.1% above forecast
 Net Corporate Income: 30.3% above forecast
 Net Miscellaneous: 3.5% above forecast

Fiscal Year Net Receipts: Net General Fund receipts for fiscal year 2017-18 were \$4.567 billion, which is 1.4% above the certified forecast of \$4.505 billion.

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board (NEFAB) on October 27, 2017. At this meeting, the NEFAB reduced the FY 2017-18 forecast by \$100 million. This forecast was divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on November 13, 2017. At the February 28, 2018 meeting, the Board revised the forecast for the current fiscal year upward by \$25 million to \$4.530 billion. By law, only downward revisions to the forecast are recertified, so the comparisons made in this release are still based on the forecast certified on November 13, 2017.
